FEES, PAYMENTS AND CHARGES FIXED UNDER THE LOCAL GOVERNMENT ACT 1972 AND THE LOCAL AUTHORITIES CEMETERIES ORDER 1974

The fees, payments and charges set out below apply where the person to be interred or in respect of whom the right is granted is, or immediately before death was, an inhabitant or parishioner of the Parish of Bradninch, or, in the case of a still-born child, where one of the parents is, or at the time of the interment was an inhabitant or parishioner. In all other cases the fees, payments and charges will be doubled if the deceased has not lived in Bradninch during the last 10 years of their life. The fees indicated for the various heads of items do not include the digging of the grave. Grave digging is arranged by the Undertaker.

Part 1 INTERMENT

For any interment in any grave of **the body** of:

| (2) | a child whose age at the time of death did not exceed 5 years, | NO CHARGE |
| (3) | a child whose age at death exceeded 5 years but was less than 18 years, | NO CHARGE |
| (4) | a person whose age at the time of death exceeded 18 years. | £370.12 |
| (5) | For an interment of cremated remains in an existing grave in respect of which an exclusive right of burial has been granted | £286.63 |

If there are two interments carried out at the same time in a CR plot the fees for the second one are halved.

Part 2 RIGHTS OF BURIALS IN EARTHEN GRAVES

| (1) | for the exclusive right of burial for a period not exceeding 100 years in an earthen grave 2 meters by 1 meter | £699.12 |
| (2) | for the exclusive right of burial of cremated remains in an earthen grave 1 meter by 1/2 meter | £549.58 |

The fees indicated for Part 2 include the Deed of Grant and all expenses thereof.

Part 3 GRAVESTONES, VASES AND MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave in respect of which the exclusive right of burial has been granted:

| (1) | a headstone not exceeding 1.25 meters in height, 0.60 meters wide, 0.38 meters deep, or a monumental vase whether or not inscribed not exceeding 0.50 meters in height | £459.85 |
| (2) | (for cremated remains) a headstone not exceeding 0.76 meters in height, 0.38 meters wide, 0.38 meters deep | £459.85 |
| (3) | to fix one vase/pot within the confines of an existing headstone | £209.36 |

The fees indicated for the various heads of this Part include the first inscription.

For each additional inscription after the first an additional fee is payable

Exhumation fee	£113.39
Transfer of Exclusive Right of Burial fee	£113.39

ALL MEMORIALS MUST BE PROPERLY AND SECURELY FIXED USING FIXINGS APPROVED BY THE NATIONAL ASSOCIATION OF MEMORIAL MASONS (NAMM) AND MUST BE REMOVED IN ACCORDANCE WITH THE PROCEDURES STIPULATED BY NAMM.

Masons must obtain approval **before** commencing work and the plot number must appear on the reverse of the memorial stone.

The above fees and charges were resolved by Bradninch Town Council.

The period covered is 14th April 2026 – 1st April 2027.
